Program Description – RAISE Grants are for investments in surface transportation that will have a significant local or regional impact, invest efficiently and equitably, promote the competitiveness of the U.S. economy, improve job opportunities by focusing on high labor standards, strengthen infrastructure resilience to all hazards including climate change, and to effectively coordinate with State, local, Tribal, and territorial government partners.

Eligible Applicants: (pg 9) States; District of Columbia; any territory or possession of the United States; local government; a public agency or publicly chartered authority; a special purpose district or public authority with a transportation function; a federally recognized Indian Tribe; a transit agency; and a multi-State or multijurisdictional group of entities.

Capital Projects (pg 10-11): (1) highway, bridge, or other road projects; (2) public transportation projects; (3) passenger and freight rail transportation projects; (4) port infrastructure investments; (5) surface transportation components of an airport project; (6) intermodal projects; (7) projects to replace or rehabilitate a culvert or prevent stormwater runoff to improve habitat for aquatic species; (8) surface transportation facilities on Tribal land; and (9) surface transportation infrastructure projects that advance the goals of the program to include intermodal and non-motorized projects.

Planning Projects (pg 11-12): (1) development of master, comprehensive, transportation corridor plans, and integrated economic development, land use, housing, and transportation plans; (2) zero emissions plan for transit fleet; (3) multimodal freight corridor plan; (4) planning activities for zero emissions goods movement; (5) port and regional port planning; and (6) risk assessments and planning to identify the transportation system's vulnerabilities and ability to withstand an emergency or major disaster.

Merit Criteria for Selection (pgs 27- 41): The DOT will consider whether the benefits are clear, direct, datadriven, and significant, which will result in a rating of "high, "medium," "low," or "non-responsive.
